# WORK AUTHORIZATION FOR F-1 VISA HOLDERS

## WHAT IS OPT? Temporary work authorization

The purpose of OPT is to gain training in your field of study for up to \*12 months\*

\*If you did any pre-completion OPT, you would not be eligible for the full 12 months

### **ELIGIBILITY TO APPLY FOR OPT**

- Job offer NOT required
- Full-time enrollment for at least 1 year of academic study
- Takes place after completion of ALL degree requirements (or in final stages of thesis/ dissertation completion)
- Present in the United States at time of application

### You are not eligible for OPT if you had:

- Full-time CPT for more than 364 days at current education level
- Already been awarded OPT at the same or higher degree level

### **SELECTING YOUR START DATE**

Know your I-20/Program End Date because it determines the OPT application timeline.

- Earliest start date can be day after program end date
- Latest start date can be 60 days after program end date

USCIS must receive your application within this time frame:

90 days before 60 days after
AND within 30 days after ISSS issues your new I-20

## APPLICATION REQUIREMENTS - 2 STEPS

### Step 1 - Apply to ISSS

- Submit Optional Practical Training (OPT) record through ISSS Portal with the following:
  - Form I-765 (follow these tips here)
  - \$150 12 month OPT processing fee

#### Step 2- Apply to USCIS

- ISSS will give you a new I-20, suggestions for your I-765, and a checklist of documents to send to USCIS. View the list of documents <u>here</u>.
- Mail everything (including \$410 filing fee) to USCIS
- Processing time can be at least 90 days



# WHAT YOU NEED TO KNOW ONCE YOU HAVE APPLIED

### **EMPLOYMENT REQUIREMENTS**

# Your position must be:

- In your field of study
- Appropriate to level of education
- Full-time (more than 20 hours/ week)\*\*

\*\*During the pandemic, the government is allowing students on OPT to work for less than 20 hours/week

#### REPORTING REQUIREMENTS

- Update ISSS when you
  - Receive an EAD
  - Receive new immigration documents (visa, passport, name change etc.)
  - Start a new position/ end a position\*
  - Address change within 10 days after move
  - Depart U.S.
- Submit OPT Employment Update record with changes in employment
- Updates to ISSS are required | SEVP Portal is optional

You are allowed a maximum of 90 days of unemployment

## TRAVEL ON OPT - NOT Recommended

#### Only travel if:

- You are employed in your field of study AND
- Have a valid F-1 Visa

If you travel, you must have the following documents:

- Valid Passport (valid for 6 months after reentry)
- Valid visa
- I-20 with OPT recommendation and travel signature
- Valid EAD
- Employment verification letter

### **60 DAY GRACE PERIOD**

## When OPT ends, within 60 days:

- Depart the U.S. before 60 day grace period ends
- Transfer to a new academic program
- Apply for change of status to another visa type
